



FAQs about Law Department - GMIU :

1. What is the **duration of the LL.B. program?**

Ans: The LL.B. program is a 3-year course divided into 6 semesters.

2. **Who can apply for admission to LL.B.?**

Ans: Students who have completed graduation from a recognized university are eligible.

3. What **career opportunities are available after LL.B.?**

Ans: Students can become advocates, legal advisors, corporate lawyers, or prepare for judicial services.

4. Does GMIU provide **practical legal training?**

Ans: Yes, students receive training through moot courts, drafting practice, and court visits.

5. Are **internships encouraged during the course?**

Ans: Yes, students are encouraged to do internships with advocates, law firms, and courts.

6. Does GMIU have a **Moot Court facility?**

Ans: Yes, the university has a well-equipped Moot Court Hall for practical courtroom learning.

7. Is there a good law **library for students?**

Ans: Yes, students get access to a well-stocked library with bare acts, law books, and journals.

8. Does the university provide **hostel facilities?**

Ans: Yes, separate hostel facilities for boys and girls are available.

9. Is **transport facility available for students?**

Ans: Yes, the university provides transport facilities from nearby cities and areas.

Ans: Yes, judges, advocates, and legal experts are invited for seminars and guest lectures.

16. How are exams conducted in the LL.B. course?

Ans: Exams are conducted semester-wise as per university academic rules and BCI guidelines.

17. Is attendance compulsory in the LL.B. program?

Ans: Yes, students must maintain 75 % attendance as per university norms.

18. Are court visits arranged for students?

Ans: Yes, court visits and legal awareness programs are organized for practical exposure.

19. Does the university provide placement guidance?

Ans: Yes, the university provides career guidance and professional development support.

20. How can I apply for admission to LL.B.?

Ans: Students can apply through the official admission process of the university or the admission office.

21. Can the Fees be paid by EMI mode?
